

**S<sup>+</sup> REWARDS x Mastercard Stamp & Earn**  
**Terms & Conditions**

1. The “S<sup>+</sup> REWARDS x Mastercard Stamp & Earn” campaign (“Campaign”) is organised by Sino Real Estate Agency Limited (“SREAL”) and Mastercard Asia/Pacific Ltd (“Mastercard”) and will be held from 30 March 2026 to 28 June 2026, both dates inclusive (“Campaign Period”).
2. The Campaign is applicable only to participating merchants located in designated malls, hotels and locations managed by SREAL, including tmtplaza, Olympian City, Citywalk, China Hong Kong City, Gold Coast Piazza, Tsim Sha Tsui Centre & Empire Centre, Island Resort Mall, Sino Plaza, One North, The Fullerton Ocean Park Hotel Hong Kong, Gold Coast Hotel Hong Kong, Cameron Plaza, Hong Kong Pacific Centre, The Humphreys, Sunshine Plaza, Sing-Ho Finance Building, The Hennessy, The Johnston, Hollywood Centre and The Centrium (“Participating Locations”).
3. This Campaign is exclusive to Mastercard cardholders. Participants must download the latest version of the S<sup>+</sup> REWARDS mobile application (“App”) and register as members (“Members”) using a valid Hong Kong, Mainland China or Macau mobile number. Each mobile number may only be registered once.
4. Members must log in to the App and click the “Join” button on the Campaign page on or before 28 June 2026 to participate.
5. During the Campaign Period, Members will earn 1 stamp for every HK\$500 spent in a single transaction using an eligible Mastercard at Participating Locations. Stamps will be automatically credited upon successful Points earning (including via Auto Earn, where applicable). For transactions not eligible for Auto Earn, Members must successfully register Points with valid merchant sales receipts and corresponding electronic payment receipts in order to earn stamps.
6. All transactions must be fully settled using an eligible Mastercard. Each sales slip must reflect a minimum spending amount of HK\$500. Cash payments, gift vouchers or other payment methods are not eligible.
7. Members must register the eligible transaction on or before 11:59pm on 12 July 2026. Approved transactions will be processed within 7 working days, and corresponding stamps will be automatically credited to the participated “Mastercard Stamp & Earn” campaign page. Members can view the number of stamps collected on the campaign page.
8. Stamps will be credited to the Campaign page within 24 hours after Points

registration approval. If any registered transaction is cancelled or refunded, the corresponding stamps will be revoked.

9. Each Member may earn a maximum of 9 stamps during the Campaign Period and may redeem each type of S Coupon once only.
10. Members may redeem S Coupons using the required number of stamps during the Campaign Period. Redemption must be completed in the App by 31 July 2026. Once redeemed, stamps will be automatically deducted and cannot be refunded or exchanged. Unredeemed stamps will be forfeited.
11. S Coupon will be distributed as below:
  - a. HK\$80 S Coupons will be issued as four (4) HK\$20 S Coupons.
  - b. HK\$180 S Coupons will be issued as nine (9) HK\$20 S Coupons.
12. Successfully redeemed S Coupons will appear under "Available" in the "S Coupons" section of "My Rewards" in the App and may be used as cash at designated merchants before the expiry date. Only S Coupons marked "Available" are valid for use.
13. All S Coupons are valid for 2 months from the date of issuance. Expired coupons will be void and will not be reissued. Any remaining balance after applying the S Coupon(s) must be settled using an eligible Mastercard.
14. All rewards are available in limited quantities and are offered on a first-come, first-served basis, while stocks last.
15. S Coupons are subject to terms and conditions, which can be found in the terms and conditions of the relevant S Coupons within the App or the S+ REWARDS Programme [Terms and Conditions](#). S Coupons are valid for use with designated merchants in Participating Malls. [The list of Merchants Accepting S Coupons](#) may be viewed on the S+ REWARDS web page and mobile app. The list of Merchants Accepting S Coupons will be updated from time to time without notice.
16. By participating in the "Mastercard Stamp & Earn" campaign, Members accept and agree to be bound by these Terms and Conditions.
17. For instalment payments, the full amount listed on the merchant's sales receipt will be counted. For deposit payments, the amount spent will be calculated as the down payment paid on that day and not as the total transaction amount.
18. Each set of eligible sales receipts and corresponding electronic payment receipts may be registered for Points only once.
19. "Electronic payment" refers to transactions made using Mastercard-branded credit, debit, or prepaid cards, including mobile payments such as Apple Pay and Google Pay. Payments made by cash, gift vouchers, or other methods are

not eligible.

20. SREAL and Participating Malls, Hotels and Locations will not be responsible for any loss, error, unidentifiable, or damaged gifts received by the Members due to any network, telephone, or technical error or problem or for any other reason not attributable to SREAL and Participating Malls, Hotels and Locations.
21. In the event of any fraud or cheating by Members, such Members will be disqualified. SREAL and the operators of Participating Malls, Hotels and Locations reserve all rights against the Members and shall have the right to withdraw any winning relevant S Coupons.
22. This promotion is held by SREAL and Mastercard. In case of disputes on this promotion or any matters incidental thereto, the decision of SREAL, the operators of Participating Malls, Hotels and Locations, and Mastercard shall be final and conclusive.
23. The terms and conditions herein are governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region. In the event of any inconsistency between the Chinese and English versions of the terms and conditions herein, the English version shall prevail.

## S+ REWARDS x Mastercard 印花賞 條款及細則

1. 「S+ REWARDS x Mastercard 印花賞」(「本活動」) 由信和地產代理有限公司(「信和」) 及 Mastercard Asia/Pacific (Hong Kong) Ltd (「Mastercard」) 主辦，推廣期為 2026 年 3 月 30 日至 6 月 28 日(包括首尾兩日)(「推廣期」)。
2. 本活動只適用於信和管理之指定商場、酒店及地點的參與商戶，包括：屯門市廣場、奧海城、荃新天地、中港城、黃金海岸商場、尖沙咀中心及帝國中心、藍灣廣場、信和廣場、朗壹廣場、香港黃金海岸酒店、香港富麗敦海洋公園酒店、金馬倫廣場、亞太中心、爵寓、陽光廣場、信和財務大廈、The Hennessy、囍寓、荷李活商業中心、中央廣場(「參與地點」)。
3. 本活動只適用於 Mastercard 持卡人。參加者須下載最新版本的「S+ REWARDS」手機應用程式(「應用程式」)，並以有效的香港、中國內地或澳門手提電話號碼登記成為會員(「會員」)。每個手提電話號碼只可登記一次。
4. 會員須於 2026 年 6 月 28 日或之前登入應用程式並於本活動頁面按下「參加」按鈕，方可參與本活動。
5. 推廣期內，會員於參與地點使用合資格 Mastercard 單一消費每滿 HK\$500，即可獲得 1 個印花。印花將於成功獲得點數後自動存入(包括適用之自動賺取點數功能)。如交易未能透過自動賺取點數功能處理，會員須憑有效商戶銷售收據及相應電子付款收據成功登記點數，方可獲得印花。
6. 所有交易必須以合資格 Mastercard 全數結算，每張銷售收據須顯示最低消費金額為 HK\$500。現金、禮券或其他付款方式恕不接受。
7. 會員須於 2026 年 7 月 12 日晚上 11 時 59 分或之前登記合資格交易。獲批交易將於 7 個工作天內處理，相關印花將自動存入已參加之「Mastercard 印花賞」活動頁面。會員可於活動頁面查看已收集的印花數量。
8. 印花將於點數登記獲批後 24 小時內存入。如任何已登記交易被取消或退款，相關印花將被撤回。
9. 每位會員於推廣期內最多可獲得 9 個印花，並只可換領每款 S 現金券各一次。
10. 會員可於推廣期內使用所需印花數量於應用程式內兌換 S 現金券。兌換須於 2026 年 7 月 31 日或之前完成。印花一經兌換將自動扣除，恕不退還或更換；未兌換之印花將被作廢。
11. S 現金券將按以下方式發出：

- a. HK\$80 S 現金券將以 4 張 HK\$20 S 現金券形式發出；
  - b. HK\$180 S 現金券將以 9 張 HK\$20 S 現金券形式發出。
12. 成功兌換之 S 現金券將顯示於應用程式「我的獎賞」內「S 現金券」欄目的「可用」狀態，並可於有效期內於指定商戶作現金使用。只有標示為「可用」之 S 現金券方為有效。
  13. 所有 S 現金券自發出日起有效期為 2 個月，逾期作廢，恕不補發。使用 S 現金券後如有餘額，必須以合資格 Mastercard 支付。
  14. 所有獎賞數量有限，先到先得，送完即止。
  15. S 現金券須受其相關使用條款及 S+ REWARDS 獎賞計劃[條款及細則](#)約束。S 現金券適用於參與商場內之指定商戶。[認受商戶名單](#)可於 S+ REWARDS 網頁及手機應用程式內查閱，並可能不時更新而不作另行通知。
  16. 會員參與「Mastercard 印花賞」活動，即表示接受並同意遵守本條款及細則。
  17. 分期付款交易將以商戶銷售收據所列之全數金額計算；如交易只支付訂金，則以當日實際支付之訂金金額計算，而非該交易之總消費金額。
