

“Disney Winter Celebration - Collectible Cards Gallery” Terms & Conditions

1. The “Disney Winter Celebration - Collectible Cards Gallery” promotion will be held from 16th November 2021 to 2nd January 2022 inclusive (“Promotion Period”). The eligible spending period will be from 16th November 2021 to 27th December 2021, inclusive (“Spending Period”).
2. The “Disney Winter Celebration - Collectible Cards Gallery” promotion is applicable only to designated malls of Sino Real Estate Agency Limited (“SREAL”), including tmtplaza, Olympian City, Citywalk, China Hong Kong City and Tsim Sha Tsui Centre & Empire Centre (“Participating Malls”).
3. This promotion is open only to S+ REWARDS members (“Members”).
4. S+ REWARDS members must be aged 11 or above. Participants under 18 must obtain the consent of their parents or guardians before providing any personal information to SREAL.
5. During the Spending Period, for every HK\$200 spent by Members in a single transaction via electronic payment at S+ REWARDS participating merchants in Participating Malls, upon successfully registering their S+ REWARDS Points (“Points”), they shall receive one (1) virtual Disney collectible card via the S+ REWARDS mobile app (“the App”) at or before 8pm on 2nd January 2022 on a random basis. Members may receive up to 10 virtual Disney collectible cards for each transaction on a random basis. For example: A member who spends HK\$2,000 in a single transaction via electronic payment shall receive 10 virtual Disney collectible cards on a random basis. A member who spends more than HK\$2,000 in a single transaction via electronic payment shall still only receive 10 virtual Disney collectible cards on a random basis. Members may access the virtual Disney collectible cards that they receive on a random basis in the App.
6. Members can receive a maximum of 50 virtual Disney collectible cards per day.
7. Members can accumulate and register up to a maximum of HK\$10,000 in spending via electronic payments per day.
8. There are 8 series of virtual Disney collectible cards (80 virtual cards in total). The virtual cards will be automatically stored in the series to which they belong after being opened by Members who have received them. After collecting a specified number of virtual Disney collectible card designs in each series, Members may redeem them for designated gifts (“Gifts”), including designated S Coupons, rare physical Disney collectible cards, designated Disney gifts and designated Disney + Calendar Card and Smart D Disney Smart Home Product Home Shopping Privilege.
9. The collected designs will not be deleted after redemption, and Members can continue to build their collection and redeem them for other designated Gifts.
10. Each member may redeem each type of Gift once in each series during the Promotion

Period.

11. For Members who have successfully redeemed Gifts (except designated S Coupons), the Gifts received will immediately be shown in “My Rewards” on the App, and they can collect the Gifts at a designated location before their expiration date.
12. For Members who have successfully claimed designated S Coupons, the S Coupons received will immediately be shown as “Redeemed/Received” in “My Wallet” on the App and can be used as cash at merchants accepting S Coupons before their expiration date. Only S Coupons with the status “Redeemed/Received” can be used.
13. Members can also redeem a virtual Disney collectible card they receive on a random basis for a physical Disney collectible card of the same design with two (2) Points. The number of physical Disney collectible cards of each design that may be redeemed by Members is equal to the number of virtual Disney collectible cards they have received on a random basis.
14. Physical Disney collectible cards cannot be combined with virtual Disney collectible cards to claim any Gifts.
15. Each virtual Disney collectible card will be issued at random by a computer, and no choice will be provided.
16. Once issued, virtual Disney collectible cards shall not, under any circumstances, be cancelled, altered, returned, or exchanged for cash or other gifts.
17. All virtual Disney collectible cards will be removed from the App at 8pm on 2nd January 2022. Members are not allowed to store or download them onto any device or electronic equipment.
18. Members must open the virtual Disney collectible cards they have received, redeem them and collect Gifts and physical Disney collectible cards at or before 8pm on 2nd January 2022. Upon expiry, any remaining virtual Disney collectible cards will be void and will not be re-issued.
19. Each set of eligible sales receipts and corresponding electronic payment receipts may only be used to register Points and participate in the “Disney Winter Celebration - Collectible Cards Gallery” promotion once and may not be used in conjunction with other promotions or offers, except Points registration and free parking offers.
20. For instalment payments, the full amount listed on the merchant’s sales receipt will be counted. For deposit payments, the amount spent will be calculated as the down payment paid on that day and not as the total transaction amount.
21. Electronic payment methods include but are not limited to credit card / debit card / EPS / Octopus / Apple Pay / Android Pay / Samsung Pay / Alipay / WeChat Pay / Tap & Go / Credit Card Cash Back Rewards. We regret that we are unable to accept receipts for transactions paid by cash, gift vouchers or other methods of payment for this promotion.
22. An event completion statement for the “Disney Winter Celebration - Collectible Cards

Gallery” promotion will be published in Sing Tao Daily and The Standard on 10th January 2022.

23. It is the responsibility of Members to check their Gifts upon receipt. Once issued, no Gifts shall be cancelled, altered, returned, exchanged for cash and/or redeemed under any circumstances.
24. By participating in the “Disney Winter Celebration - Collectible Cards Gallery” promotion, Members accept and agree to abide by these terms and conditions.
25. Points and S Coupons are subject to terms and conditions, the details of which can be found in the S⁺ REWARDS Program [Terms and Conditions](#). S Coupons are valid for use at designated merchants in Participating Malls. The list of merchants accepting S Coupons may be viewed on the S⁺ REWARDS web page and mobile app. The list of [merchants accepting S Coupons](#) will be updated from time to time without notice.
26. Disney + Calendar Card and Smart D Disney Smart Home Product Home Shopping Privilege is subject to terms and conditions. Please check with HKBN staff for details.
27. Any Gifts or virtual Disney collectible cards lost due to deleting an App account or changing a mobile phone number shall not be reissued or compensated.
28. All S coupons will expire on 31st March 2022.
29. SREAL and operators of Participating Malls shall not be liable for any lost, mistakenly used, or damaged Gifts or virtual Disney collectible cards won by Members, including any such incidents caused by network or telephone failures or problems, technical errors or any other reasons, which shall not be attributable to any fault of SREAL and the operators of Participating Malls.
30. In the event of any fraud or cheating by participants, such participants will be immediately disqualified. SREAL and the operators of Participating Malls reserve all rights against such participants and shall have the right to withdraw any issued Gifts and virtual Disney collectible cards.
31. This promotion is held by SREAL. In case of disputes on this promotion or any matters incidental thereto, the decision of SREAL and/or the operators of Participating Malls shall be final and conclusive.
32. The terms and conditions herein are governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region. In the event of any inconsistency between the Chinese and English versions of the terms and conditions herein, the Chinese version shall prevail.
